Director's Message



Dear Friends of FVPC,

Every year more than 3 million children witness domestic violence in their home in 2013 Greene County law enforcement reports reflect over 650 children were in the vicinity of a domestic incident. The effects of domestic violence are widespread in our society and the under standing and advocacy for prevention deserve some concerted attention. Childhood problems associated with exposure to Domestic Violence are indicated in the following three broad categories:

Behavioral, social and emotional problems - high levels of aggression,

anger, hostility, oppositional behavior; poor peer, sibling and social relationships and low self-worth; fear, anxiety, withdrawal, and depression,

- *Cognitive and attitudinal problems* lower cognitive functions, poor school performance, lack of conflict resolution skills, limited problem solving skills, proviolence attitudes; and belief in ridged gender roles,
- Long term problems high levels of adult depression and trauma symptoms and increased tolerance for and use of violence in adult relationships.

FVPC is pleased to be working with Children Services on the state required training and implementation of the "Safe and Together" service model as created by David Mandel and Associates. This model is to guide child protective services to keep children safe and together with the victim and address the violent and abusive behavior of the batterer, as this is the reason for the concern for the children's safety. The more effective interventions to assist all members of the family with support and accountability will provide the best option for reducing the long term effects of domestic violence.


Legislative Update

HB 129 Signed by Governor- June 17, 2014. This bill, sponsored by State Rep. Peter Stautberg, allows a workplace, association or organization to obtain an anti-stalking order when menacing or menacing by stalking is directed at a workplace or association.

HB 309 Signed by Governor- June 17, 2014. This bill, co-sponsored by State Reps. Nickie Antonio and Dorothy Pelanda, meets the federal requirement of states receiving Violence Against Women Act funding to certify that costs and fees are not assessed against petitioners in connection with the modification, enforcement, dismissal or withdrawal of a protection order, consent agreement or witness subpoena.

We are thrilled to report that the new area in our shelter building is now open to residents. The construction was complete late March which added three new bedrooms each with a full bath, a cozy lounge and a new storage room. We filled the new rooms with ten beds by the first week of April with the families on our waiting list. Our shelter building now has a total of nine bedroom units holding 32 individuals.

The first phase of the project began in 2011 and the funding received covered the cost to install the framing of the bedrooms along with the rough electric and plumbing. As more funding was sought out and awarded, the second phase began which consisted of extending the sprinkler system, installing the heating/air unit, the rest of the plumbing and electrical as well as being able to purchase materials needed to finish the project. Volunteers were recruited to assist with installing flooring, doors, window trim, bathroom fixtures and painting. We can't thank them enough for the time, care, effort and skill that was brought to the table on this enormous project!

HB 130 Signed by Governor- June 17, 2014. This bill, sponsored by State Rep. Teresa Fedor, also known as the "End Demand Act" was signed by the Governor on June 20, 2014 and is effective immediately. This bill increases the penalty for purchasing sex from a minor to a felony. Other key provisions include requiring offenders of a child 15 years and under or an individual with developmental disabilities to register as sex offenders; broadens Ohio's definition of trafficking to include fraud; prohibiting the advertisement of sexual activity for hire if the materials depict a minor; terminating parental rights for those found trafficking their children or other minors; and restricting the use of "massage" and related terms in advertising With the suggestion or promise of sexual activity.
