THE MISSION OF THE FAMILY VIOLENCE PREVENTION CENTER IS TO REDUCE FAMILY AND RELATIONSHIP VIOLENCE AND ITS IMPACT IN GREENE COUNTY THROUGH PREVENTION, INTERVENTION, SAFE HOUSING AND COLLABORATIVE COMMUNITY PROGRAMS.

SAFE HOUSING- 24 HOURS A DAY, 365 DAYS A YEAR, FVPC IS ANSWERING THE CRISIS HOTLINE, BRINGING INDIVIDUALS AND FAMILIES INTO THE PROGRAM AND RESPONDING TO THE NEEDS OF OUR RESIDENTS. UPON ENTERING OUR DOORS, CLIENTS IMMEDIATELY EXPERIENCE A VIOLENCE FREE ATMOSPHERE THAT PROVIDES FOOD, SHELTER, CLOTHING, AND MANY COMFORTS OF HOME. AS CLIENTS SETTLE IN, WE PROVIDE COUNSELING, CASE MANAGEMENT, AND EDUCATIONAL SERVICES DESIGNED TO STRENGTHEN INDIVIDUALS TO BEGIN VIOLENCE FREE INDEPENDENT LIVING. IN 2012, THE SAFE HOUSING PROGRAM SERVED 213 ADULTS AND CHILDREN FOR A TOTAL OF 7,381 SHELTER DAYS. THE CRISIS HOTLINE ANSWERED 1,994 CRISIS AND INFORMATION REFERRAL CALLS.

THROUGH INTERVENTION WE PROVIDE COUNSELING, EMERGENCY HOSPITAL RESPONSE, AND THE DOMESTIC INTERVENTION FOR VIOLENCE EMERGENCY RESPONSE TEAM (DIVERT). FVPC TAKES A HOLISTIC APPROACH TO ENDING DOMESTIC VIOLENCE BY CONDUCTING THERAPEUTIC AND EDUCATION COUNSELING SESSIONS THROUGH A BATTERERS INTERVENTION PROGRAM CALLED DOMESTIC VIOLENCE INTERVENTION PROGRAM (DVIP) FOR ADULTS AND CHOICES FOR YOUTH. IN 2012, 358 INDIVIDUAL ADULT AND 150 INDIVIDUAL CHILD COUNSELING SESSIONS WERE PROVIDED; DIVERT RESPONDED TO 454 DOMESTIC VIOLENCE POLICE CALLS AND FOLLOWED UP WITH 239 DOMESTIC DISPUTE REPORTS; AND 41 CLIENTS PARTICIPATED IN DVIP.

IN ADDITION, THE FAMILY ADVOCATES SCREEN RELATIONSHIP EDUCATION PARTICIPANTS FOR DOMESTIC VIOLENCE THROUGH A MULTI-COUNTY AREA.
