Legislative Update-

Senate Bill 177, effective March 23, 2015. The legislation explicitly allows judges to include pets when issuing the following protection

order types: civil stalking, sexually oriented offense and domestic violence. Judges may order an alleged offender "not remove, damage, hide, harm or dispose of any companion animal owned or possessed by the person to be protected" or authorize the victim to remove the animal from the offender.

Call to Action – Please consider providing support for these two specific initiatives.

Shielding Victim Addresses

Legislation has been reintroduced by Senator Sandra Williams that would enable domestic violence victims who are protected under court orders to have their government related mail sent directly to the Secretary of State's Office. That office would then forward the mail to participants, whose addresses would not be included in public records. This marks the fourth consecutive general assembly where this legislation will be introduced. In 2010, a comparable bill was supported by then-Secretary of State Jennifer Brunner and passed the Ohio House on a unanimous vote before stalling in the Senate. None of the subsequent bills moved out of either of the chambers. Contact your local representatives and senator to share your interest in action.

More than three dozen other states have similar address confidentiality programs in place that are administered by secretaries of state, attorneys general or nonprofit agencies

Strangulation as a Felony

Strangulation is used to enforce power, control, and terror in the victim's life. There are specific strangulation laws in 30 states and Ohio needs to join this group. The 2008 Journal of Emergency Medicine analyzed 300 murders in 11 U.S. cities and showed that 43% of women who had been murdered in domestic assaults and 45% of attempted murder victims had been strangled in the previous year by their male partners. 


In 2014, FVPC earned \$438.52 - THANK YOU! Upon last report, we had 11 households registered. We know we can increase this fundraising potential with your help.

Participation increased from last year and we made it a light-hearted experience while at the same time adding important information for teenagers to know. Chaplain's Report



For the past five months, I have been serving as the volunteer Chaplain for FVPC. Building on 30 years as a pastor and 10 years as a small group leader for a weekly support group, I'm attempting to function in part as FVPC's CMO (Chief Morale Officer). Each week I send out a "Thought for the Week" to our hard-working, talented staff in an attempt to thank them and encourage them as they continue this often challenging work. I encourage any readers to consider passing on words of thanks and encouragement to them as well when the opportunity arises.

Believing that our safe house residents could benefit from a group that involves male leadership, I have also started a group called, "Moving On". Those who come to these Tuesday evening gath-

erings are given an opportunity to talk about something relevant to this critical transition moment in their lives. So far the participation has been enthusiastic and the conversations lively.

It is also my intention to reach out into our community, especially to the churches of Greene and Montgomery counties to try to build bridges of education and support between the community at large and the people living and working at our center. For several months, I have gathered and developed resources to distribute to interested clergy and am in the process of trying to meet with them one on one. Included in my "bag of tricks" is a workshop for men which I recently led at Bellbrook UMC and hope to repeat in other congregations. Men need to learn how we contribute to the society that has tolerated domestic violence staying under the radar for far too long.

It is my hope to build an FVPC Community Spiritual Support Network. The more we learn about what we can do to help stop domestic violence and minister to those involved in it, the more pain and suffering we can relieve or stop from happening.
