**October** is domestic violence awareness month. Throughout the month FVPC has participated in multiple events throughout the community. This year we have enjoyed opportunities to visit college campuses to speak in classes

**Power of the Purse -Financial Abuse is Real**: Financial abuse is self-identified by victims 99% of the time when they share what they are experiencing from the abusive partner. This indicates a main resource needed to generate a change. When individuals who have not experienced domestic violence ask ,"Why doesn't the victim just leave?" this question is coming from a station of privilege, where a person has not been victimized. Seventy-eigth percent of Americans polled about finacial abuse did not recognize financial abuse as a form of domestic abuse. (Adrian Adams, CFS, Research Brief 2011.) Financial abuse can take the following forms: abusive partner prohibits victim from working, calls and comes to the victim's place of employment to be disruptive, gives victim an allowance, keeps the finances away from the victim, puts utilities in the victim's name with slow or no payment, obtains credit cards or loans in the victim's name with slow or no payment. Thinking of the financial trap described here, imagine the difficulty and why victims cannot "just leave."

**Call to Action**: In the April of 2019 the US House of Representatives passed the updated version of the Violence Against Women Act (VAWA) in house bill HR 1518. Now the Senate needs to move to vote for the Reauthorization of VAWA. This act has long enjoyed bipartisan support. # purple purse challenge in full swing

**FVPC** participated in the Allstate Purple Purse Challenge again this year to promote awareness concerning financial abuse. This abuse causes major obstacles for a victim who is trying to leave their abuser. Purple Purse Challenge is meant to show us how important financial stability is to a victim's successful transition out of an abusive relationship.

Financial Abuse is Real...

When most people think of domestic violence they think of verbal and physical abuse, but research shows that financial abuse is just as common in unhealthy relationships as any other types of abuse. As we shared, 99% of domestic violence victims disclose that financial abuse and control was present in their relationships. This staggering statistic explains why it is hard for victims to "just leave". **T**his year at FVPC, we had a great example of a victim's success. She arrived at our safe house defeated with little to no ownership of anything due to years of financial abuse and domestic violence. Through our programming such as life skills, process group, and case management, this client was able to get a job, secure permanent housing and gain her independence back. She moved into her own house with visible confidence! October is recognized as National Domestic Violence Awareness Month. Throughout the month of October, we hosted an online fundraiser, *Power of the Purse*, which is a campaign intended to raise necessary funds for the mission of FVPC and to understand the realities of victims' experiences. We also wrapped up our month-long focus with the *Purses and Pastries* luncheon. We are so grateful to all who attended.Every

dollar donated online for this event *was matched* by HealthPath Foundation. With your help, we made our matching goal of \$5,000! This was a great way to double your postive impact for the FVPC mission.
