FVPC IS BUSY ANSWERING THE CRISIS HOTLINE, BRINGING INDIVIDUALS AND FAMILIES INTO THE PROGRAM, AND RESPONDING TO THE NEEDS OF OUR RESIDENTS. UPON ENTERING OUR DOORS, CLIENTS IMMEDIATELY EXPERIENCE A VIOLENCE FREE ATMOSPHERE THAT PROVIDES GOODS, SHELTER, CLOTHING AND MANY COMFORTS OF HOME. AS CLIENTS SETTLE IN, WE PROVIDE COUNSELING, CASE MANAGEMENT, AND EDUCATIONAL SERVICES DESIGNED TO STRENGTHEN INDIVIDUALS TO BEGIN VIOLENCE FREE INDEPENDENT LIVING. IN 2020, FVPC HOUSED 300 SURVIVORS OF DOMESTIC VIOLENCE FOR A TOTAL OF 8,814 SAFE SHELTER NIGHTS.

PREVENTION: PREVENTION IS IMPERATIVE FOR ENDING VIOLENCE AND PROMOTING THE SUCCESS OF VIOLENCE FREE FUTURES. FVPC CONDUCTS PREVENTION EDUCATION SESSIONS IN MIDDLE SCHOOLS AND HIGH SCHOOLS THROUGHOUT GREENE COUNTY. FVPC SECURED MORE CONSISTENT FUNDING FOR THE PROVISION OF SAFE DATES TO THE MIDDLE SCHOOLS AND HIGH SCHOOL YOUTHS OF GREENE COUNTY. DURING 2020 WE WERE ABLE TO PROVIDE CLASSES VIRTUALLY AND IN PERSON ACCORDING TO THE SCHOOLS DISTRICTS DIRECTIONS IN ACCORDANCE WITH COVID PRECAUTIONS. GREENE COUNTY JUVENILE COURT SUBCONTRACTED WITH FVPC TO CONDUCT PREVENTION SERVICES WITH YOUTH IN THEIR ASSESSMENT CENTER.

THROUGH INTERVENTION, WE PROVIDE COUNSELING, EMERGENCY HOSPITAL RESPONSE, AND THE DOMESTIC INTERVENTION FOR VIOLENCE RESPONSE TEAM (DIVERT). FVPC TAKES A HOLISTIC APPROACH TO ENDING DOMESTIC VIOLENCE BY THE CONDUCTION OF THERAPEUTIC AND EDUCATIONAL COUNSELING SESSIONS THROUGH A BATTERER'S INTERVENTION PROGRAM CALLED DOMESTIC VIOLENCE INTERVENTION PROGRAM (DVIP) FOR ADULTS. IN 2020 COUNSELING SESSIONS WERE ABLE TO BE OFFERED VIRTUALLY. FVPC SERVES AS THE AS THE CERTIFIED RAPE CRISIS CENTER FOR GREENE COUNTY.
